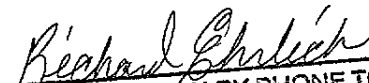
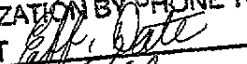
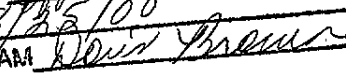

ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE  
NAME

The name of the corporation is INTERNET VENTURES OF CORAL SPRINGS FLORIDA, INC.

PRINCIPLE LOCATION
