ARTICLES OF INCORPORATION OF JACQULYN M. DAVIS ENTERPRISES, INC.



ARTICLE I NAME OF CORPORATION

The name of the corporation is JACQULYN M. DAVIS ENTERPRISES, INC. .

ARTICLE II
DURATION OF CORPORATION

The period of its duration is perpetual.

ARTICLE III PURPOSE OF CORPORATION

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE IV CAPITAL STOCK

STOCK TRANSFER RESTRICTION. No shareholder of this corporation shall sell any shares of stock held by him or her in this corporation without first offering to sell such stock to the corporation on the same terms and conditions and the price offered in good faith and in writing by any proposed purchaser.

ARTICLE X BYLAWS

The bylaws of this corporation shall be for the government of this corporation and may contain any provisions or requirements for the management or conduct of the affairs and business of this corporation, provided the same are not inconsistent with the provisions of these Articles of Incorporation, or contrary to the laws of the State of Florida or of the United States.

ARTICLE XI AMENDMENT OF ARTICLES OF INCORPORATION

The corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the stockholders herein are subject to this reservation.
