In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE 1

The name of the corporation ("Corporation") is AUTOMOTIVE STRATEGIES, INC.

ARTICLE 2

The existence of the corporation shall begin immediately effective upon the acceptance of these Articles of Incorporation by the Florida Secretary of State.

ARTICLE 3

ARTICLE 4

The maximum number of shares this Corporation is authorized to issue is two thousand (2,000), all of which shall be Common Shares with par value of one cent (\$0.01) per share.
