ARTICLE I. NAME

The name of this corporation shall be SUPREME WOODWORKING CORPORATION.

ARTICLE II. PRINCIPAL OFFICE

The mailing address and principal place of business of the corporation is 6600 Georgia Avenue, Bay 2, West Palm Beach, FL 33405.

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of signing of these Articles of Incorporation. This corporation's duration shall be perpetual.

ARTICLE IV. PURPOSE

The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

The name of the individual who shall serve as this corporation's initial registered agent at that address is: Jeffrey H. Gibson.


ARTICLE VIII. INCORPORATOR



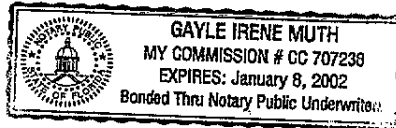


