I, the undersigned, whose name is hereunto subscribed, make this certificate for the purpose of forming a corporation to be known as PASCO PATHOLOGY SERVICES, INC, and hereby associate ourselves together for the purpose of becoming such corporation for profit under the laws of the State of Florida for the purpose and with the rights, powers and objects hereinafter set forth as follows:

**ARTICLE I**

**NAME**

The name of the corporation shall be PASCO PATHOLOGY SERVICES, INC.

**ARTICLE II**

**ADDRESS**

The initial street address of the principal office of this corporation in the State of Florida is 5303 Locust Place, New Port Richey, Florida 34652-3736. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

**ARTICLE III**

**NATURE OF BUSINESS**

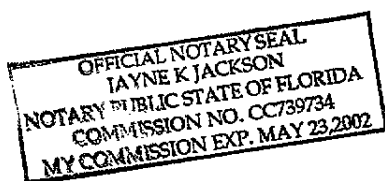

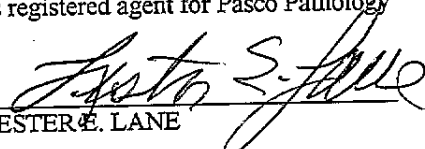
