

CORPORATE NAME**

The name of this Corporation shall be *SACHA COSMETICS, INC.*, and its principal office shall be located at *555 S. FEDERAL HIGHWAY, SUITE 330, BOCA RATON, FL 33432.*

**ARTICLE II  
NATURE OF CORPORATE BUSINESS AND POWERS**



CONTROL SHARE ACQUISITIONS**


