Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation, **BUCCANEER CHARTER & BAIT, INC.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

1. **Name of the Corporation.** The name of the Corporation is Buccaneer Charter & Bait, Inc.
2. **Text of the Amendment.** The amendment changes the name of the Corporation to **BUCCANEER FISHING CHARTERS, INC.** Accordingly: Article I, Name, of the Articles of Incorporation is amended in its entirety to read as follows:


ARTICLE I - NAME
