

KNOW ALL MEN BY THESE PRESENTS: That the undersigned individual does hereby incorporate a corporation under the provision of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be and is POE'S PLASTER PLACE, INC. located at 1226 Overlook Road, Eustis, FL 32726.




