ARTICLES OF INCORPORATION

OF

LOUIS P. SERVO, INC.

THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of the corporation is:

Article II - Location and Mailing Address

The general purpose for which the Corporation is organized is the renovation of commercial buildings and any and all lawful business for which Corporations may be incorporated under the Florida General Corporation Act, the laws of the State of Florida or of the United States of America.

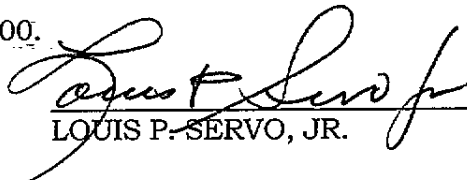

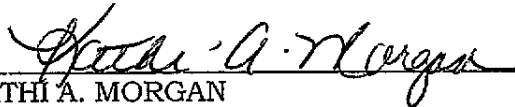
