**ARTICLE I - NAME**

The name of the Corporation shall be WEB KEY , INC.  
a Florida Corporation.

**ARTICLE II - PURPOSE**

This Corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLES III - POWERS**

This Corporation shall have all of the powers enumerated in the  
"Florida General Corporation Act", (Chapter 607,  
Florida Statutes).

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 10,000 shares of voting common stock  
(one thousand shares), with a par value of \$1.00 (one dollar) per share.

**ARTICLE V - PREEMPTIVE RIGHTS**

Such preemptive right shall apply to such the shares whether such additional shares constitute a part of the shares presently or subsequently authorized or constitute shares held in the treasury of the Corporation and shall be exercised in the respective ratio with the number of shares held by each stockholder at the time of such issue bears to the total number of shares outstanding in the names of all stockholders at such time.
