ARTICLE - V

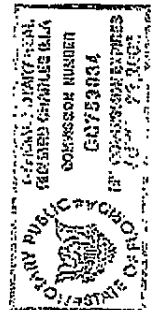
INITIAL AND PRINCIPAL REGISTERED OFFICE AND AGENT
