The undersigned, acting as incorporator of YOLANDA TRAVEL, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation is YOLANDA TRAVEL, INC.

ARTICLE II. ADDRESS

The mailing address of the Corporation is 16322 Bonnevill Drive, Tampa, Florida 33624.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence upon the filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VIII. INCORPORATOR


ARTICLE IX. BYLAWS


