The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be GROUT BUSTERS SYSTEMS, INC. The address of the principal office of this corporation shall be 410 E. Paris Street, Tampa, FL 33604, and the mailing address of the corporation shall be the same.

**ARTICLE II. NATURE OF BUSINESS**


