ARTICLES OF INCORPORATION
OF
UNDERGROUND PRECISION, INC.

The undersigned, acting as incorporator UNDERGROUND PRECISION,
under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is UNDERGROUND PRECISION, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of August 23, 2000.

ARTICLE III. PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The Street address of the initial office of the corporation is 15363 SW 165 Street, Miami, Florida 33187 and the name of the corporation's initial registered agent is Sonia L. Perdomo whose address is 15363 SW 165th Street Miami, Florida 33187.

ARTICLE VI. INITIAL BOARD OF DIRECTORS

Thereafter, every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a shareholders' meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.



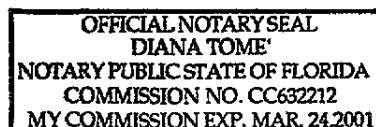




ACCEPTANCE OF APPOINTMENT AS REGISTERED AGENT
