ARTICLES OF INCORPORATION
OF
MISSION MARTI NETWORK, INC.

ARTICLE I

The name of the corporation is MISSION MARTI NETWORK, INC., (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 346 Malaga Ave. Coral Gables, FL 33134

ARTICLE III

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

The Corporation shall hold a special meeting of shareholders only:

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

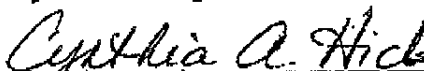
