

00 AUG 24 PM 12: 13 The undersigned incorporator (s), for the purpose of forming a corporation under the Florid Business Corporation Act, hereby adopt (s) the following Articles of Incorporation.

ARTICLE I CORPORATE NAME

The name of this Corporation shall be: L.M.G. LIMITED, INC. located at 128 Pelican Drive, Melbourne Beach, FL 32951

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 128 Pelican Drive, Melbourne Beach, FL 32951.

ARTICLE III NATURE OF BUSINESS AND POWER

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV CAPITAL STOCK

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon filing of these Articles.
