**ARTICLE I - NAME - LOCATION**

The name of this corporation is ROLLO SHUTTERS, INC, located at 4460 North Federal Highway, Fort Lauderdale, Florida 33308.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these articles.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue Five Hundred (500) shares of ONE DOLLAR (\$1.00) par value common stock which shall be designated "Common Shares".


ARTICLE IX - AMENDMENT




