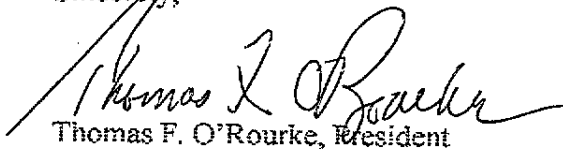

The aggregate number of shares of stock and its par value that this corporation is authorized to have outstanding at any one time is:

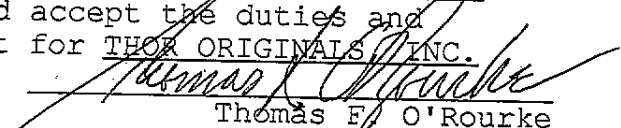
