ARTICLES OF INCORPORATION OF OLD 484 PAWN & GUN SHOP, INC.

- 1. The name of this Corporation is OLD 484 PAWN & GUN SHOP, INC.
- 2. The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida including, but not limited to, the operation of a pawn shop.
- 3. The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share.
- This Corporation shall have perpetual existence commencing upon filing of these Articles.
- 5. The Registered Agent and the street address of the initial registered agent of this corporation in the State of Florida shall be: JEAN A. BAER, 5910 S.W. 112th Place Road, Ocala, FL 34476, who by signature herein is accepting designation as Resident Agent.
- 6. The initial stockholders will be as follows:

Shares held by each shareholder may not be sold or otherwise transferred to other persons or other entities, except as follows: a) sold back to the corporation at a price agreed to between the seller and remaining shareholders; b) to any third party after a right of first refusal lasting 30 days after receipt of written notice has expired, such right of first refusal being held by the corporation; or c) to any third party after a right of second refusal lasting 30 days after receipt of written notice has expired, such right of second refusal being held by the remaining shareholders.
