ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract, hereby file for record the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

HERBERT ELLIOTT, P.A.

ARTICLE II. PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The principal place of business of this corporation shall be 35 West Lemon Street, Tarpon Springs, Florida 34689. The name of the initial registered agent of the corporation, located at that office, is Herbert Elliott.

ARTICLE III. DURATION

This corporation is to exist perpetually, or until dissolved on a vote of the shareholders as provided in these Articles.

ARTICLE IV. PURPOSE

The purpose of the corporation is to practice the profession of law. The sole and exclusive professional service to be rendered by the corporation is the practice of law.

ARTICLE V. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding is 100 shares of common stock having \$1.00 par value per share.

ARTICLE VI. CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of law is not less than \$1,000.00.

ARTICLE VII. CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

ARTICLE VIII. INCORPORATOR

ARTICLE IX. DIRECTORS

The Corporation is to be managed by a board of directors and the Corporation shall have one director initially.
