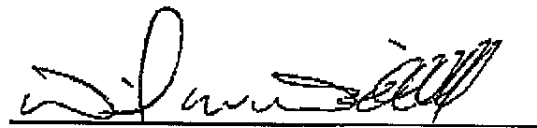
ARTICLE X.

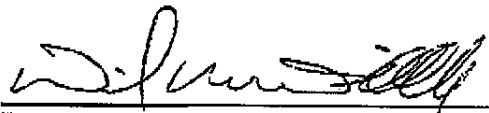
