**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural person(s), do hereby act as incorporator(s) in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

ARTICLE V

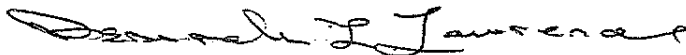

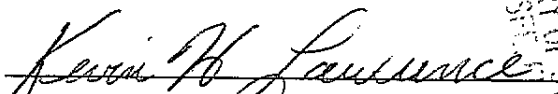

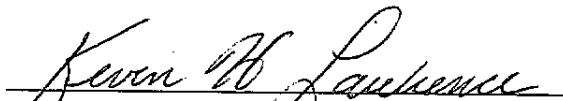
