ARTICLES OF INCORPORATION
ORLANDO SUNSHINE TOURS & TRANSPORTATION, INC.

ARTICLE I. NAME

The name of this corporation shall be Orlando Sunshine Tours & Transportation, Inc.

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation by the Department of State.

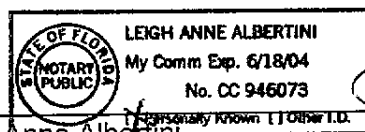


