ARTICLES OF INCORPORATION CASEY TOOL & MACHINE, INC.

ARTICLE I - NAME

The name of this corporation is CASEY TOOL & MACHINE INC. and the principal office or mailing address of the corporation is 2225 Guava Drive, Edgewater, Florida 32141

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of the Articles with the Department of State.
