ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is CASEY TOOL & MACHINE  
INC. and the principal office or mailing address of the

ARTICLE II - DURATION

The corporation shall have perpetual existence  
commencing on the date of this filing of the Articles with


