ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

I, the undersigned, natural person of the age of twenty-one or more, for the purpose of organizing a corporation pursuant to the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of the corporation is R.F. BROWN MANAGEMENT, INC.

ARTICLE II

Principal Office

ARTICLE III

<u>Purpose</u>

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

Capital Stock

The aggregate number of shares which this corporation shall have authority to issue is 50,000 shares of common voting stock, all of which shall have no par value and all of which are of the same class.
