The undersigned represents Pinnacle Leasing, Inc., as registered agent.

I just became aware that the above referenced corporations are listed as delinquent, for failing to timely file the 2002 Uniform Business Report. It is my understanding that the Uniform Business Reports, sent by the Department of State, to my former office at 300 Northwest 82<sup>nd</sup> Avenue, Suite 412, Plantation, Florida 33324 were returned to your office as "legal mail not forwarded".
