NAME

Pursuant to Florida Statutes, Section 6070203, this corporation's existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

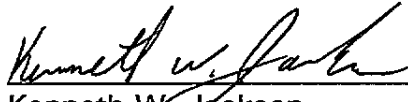
ARTICLE X
