ARTICLE I - NAME

The name of this Corporation is MIRAHE CORPORATION

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing  
on August 25, 2000.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted


