# ARTICLES OF INCORPORATION

OF

## JOHN SCHWEMLER ENTERPRISES, INC.

The Undersigned incorporator(s), for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.
