The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

### <u>ARTICLE I - NAME</u>

The name of this corporation is JAKE'S UNLIMITED, INC., (hereinafter "Corporation").

### ARTICLE II - PURPOSE OF CORPORATION

This Corporation is organized for the purpose of transacting any lawful business for which corporations may be organized under the laws of the United States and the State of Florida.
