ARTICLE I. NAME AND PRINCIPAL ADDRESS

The name of this corporation is UNITED SENIOR CARE, INC..
The principal address of the corporation is 7655 West Gulf to Lake

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the 1st day of
September, 2000.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of engaging in
any activity or business permitted under the laws of the United

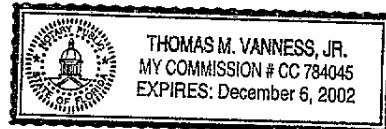
