ARTICLE XIII - INDEMNIFICATION

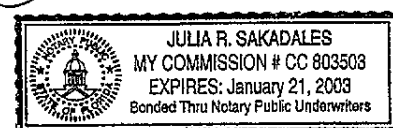




