**ARTICLE I - SHREE LAXMI, INC.**

The name of this corporation is Shree Laxmi, Inc.

**ARTICLE II - PURPOSES**

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

**ARTICLE III - CAPITAL STOCK**

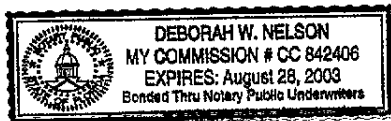


