ARTICLES OF INCORPORATION

OF

CHRISTINE R. MILLER, P.A.



Pursuant to the provisions of the Professional Services Corporation Act of the State of Florida the undersigned Christine R. Miller, being a duly licensed real estate agent does hereby make, organize and form a professional service corporation under the following Articles of Incorporation to wit:

ARTICLE I - NAME
