ARTICLES OF INCORPORATION
OF
GULF SHORES HOLDINGS II, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Gulf Shores Holdings II, Inc. and the principal address and principal place of business is 6800 North Dale Mabry Highway, Suite 268, Tampa, Florida 33614.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE III - PURPOSE
