

**ARTICLES OF INCORPORATION**  
**OF**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is Sheffield Leisure, Inc.

**ARTICLE II**

The existence of the corporation shall begin on October 1, 2000.

**ARTICLE III**





The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


