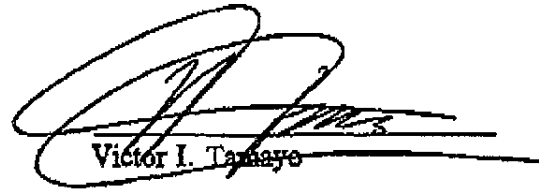
**ARTICLE XI-AMENDMENT**
