The undersigned, acting as the incorporator of this Corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION

The name of the corporation is: MANUEL GARCIA-FRANGIE, MD, PA.

ARTICLE II: MAILING ADDRESS OF THE CORPORATION

The mailing address of the Corporation is: 4944 NW 102ND AVENUE; #102;, Miami, Florida 33178.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION

The general purpose for which the corporation is organized is to engage in any and every aspect of the practice of medicine in the specialty of family medicine.

ARTICLE V: AUTHORIZED SHARES
