ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Gypsie Wind Corporation

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: Suite 23 7050 W. Palmetto Park Rd. Boca Raton, Florida 33433

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
