**ARTICLES OF INCORPORATION
OF
CABLEPRO INCORPORATED**

ARTICLE I - NAME

The name of this corporation is CABLEPRO INCORPORATED.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

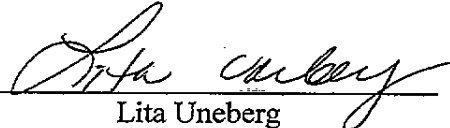

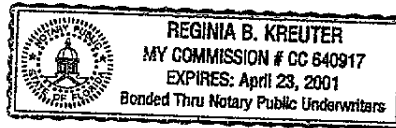
