THIRD: The amendments were adopted by the Board of Directors on the 3<sup>rd</sup> day of April, 2003.

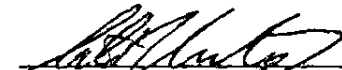
FOURTH: The amendments were approved by a majority of the members of the corporation on the 3<sup>rd</sup> day of April, 2003.

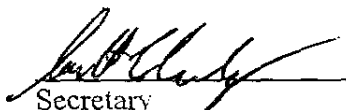
