adopts the following articles of amendment to its articles of incorporation.**

FIRST: Amendments adopted:

ARTICLE IV – PURPOSE:

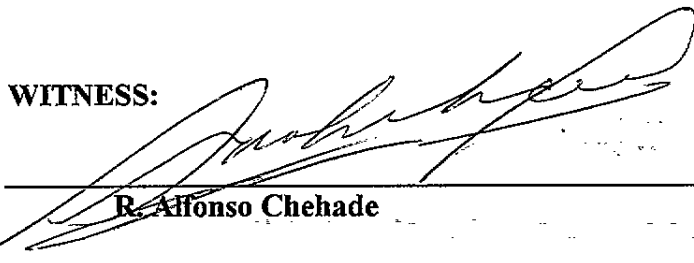
