The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statute, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I - NAME AND PLACE OF BUSINESS

ARTICLE IX - AMENDMENT




