Ladies and Gentlemen:

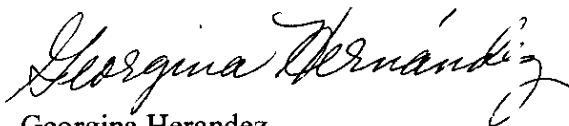
