**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Go Hyang Zip, Inc.

ARTICLE II

The existence of the corporation shall begin on September 1, 2000.

ARTICLE III

The purposes for which the Corporation is formed are to own, maintain and operate a restaurant business, and to engage in any other lawful purpose and business.

ARTICLE IV

The street address of the principal office of the corporation is 1400 West Oak Ridge Road, Orlando, Florida 32819.

ARTICLE V

The maximum number of shares this corporation is authorized to issue is 100,000 with \$1.00 par value, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

The initial street address of the Corporation's registered office is 1400 West Oak Ridge Road, Orlando, Florida 32819. The initial registered agent for the Corporation at that address is Jin S. Chung.


