ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NETADVISORS REALTY, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Delete Article VII "Directors" from the Articles of Incorporation and substitute the following in its place and stead:

"This Corporation shall have two (2) directors initially. The number of directors may be increased or decreased (by a unanimous vote of all shareholders of the Corporation), but not to less than one (1) from time to time by the holders of a majority of the outstanding shares of the Corporation at any regular or special meeting of shareholders, but no decrease shall have the effect of shortening the term of an incumbent director (unless the shareholders remove the director).

THIRD: The date of this amendment's adoption: October 25, 2000
