## ARTICLES OF AMENUMENT TO ARTICLES OF INCORPORATION

- 1. The name of the corporation is Aspedient Technologies, Inc., a Florida corporation (the "Corporation").
- 2. Article Ill of the Articles of incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

### ARTICLETT

The Corporation is authorized to issue an aggregate of Twenty-five Million (25,000,000) Shares, all of which shall be designated Common Stock, having a par value of \$.001 per share.

3. Article VII of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

### ARTICLE VII

The number of shares of common stock cast in favor of these Articles of Amendment was sufficient for approval.
