# ARTICLE I

# **Corporate Name and Principal Office**

The name of this corporation is Web Marina.com Holdings, Inc. and its principal office and mailing address is 1211 Tech Blvd., Suite 101, Tampa, FL 33619.

#### ARTICLE II

# Commencement of Corporate Existence

The corporation shall come into existence on August 24, 2000.

#### ARTICLE III

## **General Nature of Business**

This corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida.

#### ARTICLE IV

#### Capital Stock
