Article V, Terms of Existence

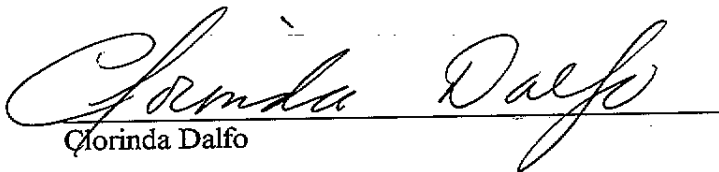
This corporation shall exist perpetually.

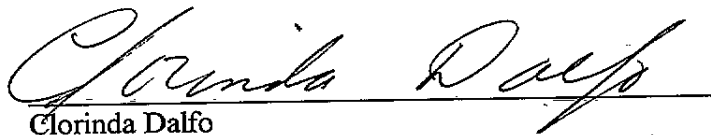
